**KELLY FITZPATRICK MEMORIAL GALLERY
EXHIBITION AGREEMENT**

Name _____, hereafter referred to as the Exhibitor.

In consideration of The Kelly Fitzpatrick Memorial Gallery (The Kelly) allowing the exhibitor, to exhibit artwork either online or on the premises of The Kelly's as a means of promoting the arts to the citizens of Wetumpka and the public, The Exhibitor, desiring to voluntarily participate in this Exhibit, does hereby acknowledge and agree as follows:

The Kelly has the right to deny the exhibition of any particular piece of art or artwork, if in its sole discretion, it is deemed unsuitable for any reason to be displayed online or on its property.

I understand and agree that The Kelly do not warrant the safety or security of any artwork on display on said property, and I specifically agree to hold The Kelly, their members, employees, officers, volunteers, and/or agents, harmless from any damages or claims for damages sustained to any artwork displayed on The Kelly's..

Knowing the risks of damage or loss that may occur to my artwork being displayed on The Kelly's property, which is open to the public, I voluntarily assume responsibility for any risk of property damage and/or loss that may be sustained as a result of participating in this Exhibit.

I do hereby authorize The Kelly, and their agents and assigns, to take and use photographs of my artwork for the purposes of preparing a catalog (either printed or on-line) and publicizing this event, in such manner and at such times as it deems appropriate. No other reproduction of the artwork is authorized.

Furthermore, I, individually and for my heirs and assigns, do voluntarily waive, release, hold harmless, discharge, and indemnify The Kelly, from any and all claims that I, and/or my heirs or assigns, may have in the future, including but not limited to property damage, that I may incur as a result of my participation in the Exhibit, whether directly connected to these activities or not, however caused, or as a result of the condition of the premises where the Exhibit occurs.

Finally, I do hereby agree to remove my artwork from the Kelly's premises within 30 days from the last date of public display for the Exhibit. My failure to remove my artwork in 30 days shall mean that I have decided to convey the artwork to The Kelly as consideration for their displaying the art during the Exhibit. Should that event so occur, I do hereby grant, bargain, sell, and convey all my right, title, and interest in and to the artwork which is subject of this agreement unto the Kelly outright and in fee simple absolute, for them, their successors and assigns, to have and to hold forever, free from all contingencies and encumbrances thereon. This paragraph shall be null and void and of no force or effect should I remove my artwork within the allotted time following the end of the Exhibit.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN ME AND THE KELLY.
