

HOLIDAY ARTIST MARKET

Join us this year for our annual Holiday Artist Market, where artists are invited to exhibit and sell their fine arts, handmade crafts, and other artistic labors of love. Bring your art, and The Kelly will handle the display and sales. The Artist Market will also coincide with Wetumpka's Dicken's Christmas and Christmas on the Coosa events.

JURIED MARKET RULES

This will be a juried market, so please understand space is limited and not all of your entries will be chosen. The Kelly has limited space and storage; thus, artwork(s)/object(s) are juried based on quantity and other similar objects. Artwork(s)/object(s) dropped off without The Kelly's prior approval, notification, or consent will not be displayed and instead be returned to the Artist.

COST:

Participation is free for members of The Kelly, all others pay a \$25.00 set up fee.

ORIGINAL ART AND CRAFT WORKS ACCEPTED:

1. All art, prints, and/or craft work(s) must be created by the applicant—no reproductions of other people's works. Use of trademarked or copyrighted materials is not permitted, unless the artist provides (and includes with each object) a statement from the original owner providing legal and written consent for its usage.
2. Crafts that take a pre-existing material (ex. figurines, silverware, retail items, etc.) and change it into a different form may be acceptable so long as the object is appreciably altered by the artist, to be approved on a case-by-case basis.

COMMISSION:

A twenty-five percent (25%) donation to The Kelly will be deducted from any sales during this exhibit.

APPLYING:

1. Artists must submit an application and photos of their entries, which may be emailed to Exhibits@TheKelly.org, submitted online at <https://thekelly.org/exhibitions/exhibit-application/>, or a jump drive mailed to PO Box 641, Wetumpka AL 36092. Please ensure submissions are received by November 2nd.
2. Artists will be notified by email or phone on or before November 15th if they have been accepted and which pieces.
3. Accepted art should be delivered to The Kelly at 301 Hill Street, Wetumpka, AL 36092 on November 25th or 26th. If you are unable to deliver your art at this time, please contact us, prior to this date to make other arrangements. If art is delivered after this date, we are not able to guarantee a space on the walls.
